

Analytical Instrument Facility (ICAR-IISWC)

Though limited in number, a variety of analytical instruments are available, being operated and maintained at ICAR- IISWC Dehradun by qualified technical personnel and scientists. The Institute is committed to promote an "open access policy" for equipment use and analysis services. The idea is to extend benefit from the services of Analytical Instrument Facility (AIF) to different researches and students and other users in larger national interest.

The main objectives of AIF facilities are:

- To provide for guidance acquisition of data using analytical Instruments.
- To organize workshops on the use and application of analytical techniques. for students, teachers and personnel from other Laboratories, Universities and Industries.
- To provide facilities of analytical instruments to scientists and other users from academic institutes, R&D laboratories and industries
- To enable them to carry out measurements for R&D work.

How to use the Facility

Registration:

Registration is essential to gives a priority number and provides a reference to your sample.

External Users :

University/ Colleges/ National Lab:

You can come in-person or send your samples along with a letter from the Head / Guide on your College/Institute original letter head duly signed and sealed for registration stating **the purpose of analysis** as it may qualify for academic concession. The letter should be addressed to The OIC, Central Lab, IISWC, Dehradun.

Other users

You can come in-person or send your samples along with a letter for registration.

Covering letter should be on your company original letterhead duly signed and sealed and should also consist the following undertaking:

"In any event, the content of report/bill is meant for our information only and we will not use the content of this bill/report for advertisement, evidence or litigation."

If your letter does not contain the above undertaking then your letter and samples for analysis will not be accepted.

- In your letter mention that "You agree to acknowledge AIF, IISWC Dehradun, in your publications and thesis if the AIF Instrument results are incorporated/used in them."
- Kindly send us the publication reference (Journal name/volume number/names of the authors/date of issue of the publication etc) to us.

- For any further details mail to office.

Note:

The analytical data is provided only for research / development purposes. These cannot be used as certificates in legal disputes.

All the users are required to submit MSDS (Material Safety Data Sheets) for each sample they submit and a certificate stating that the samples submitted are non- toxic/ non-hazardous and that the sample does not require special precaution while handling.

Note:

1. Samples, letter and payment should be sent in the same cover only
2. If Samples are received without covering letter/DD, the samples will be sent back to the user without any further intimation/notice.
3. Separate Sample should be sent for different analysis.
4. All the samples should accompany the payment, in order to be considered for registration and analysis. Samples are not analysed till Payment is received.
5. GST is applicable to all the users and is calculated as per current rate (presently 18%)
6. All the payments should be in favour of "The Director, IISWC, Dehradun "
7. The DD should be rounded off the nearest figure (integer value).
(Example: IF total charges (including tax etc) comes out to be Rs.450.67/- (ie greater than or equal to 50 paise) then DD amount should be rounded off to Rs.451/- IF total charges (including tax etc) comes out to be Rs.450.43/- (ie less than 50 paise) then DD amount should be rounded off to Rs.450/-)
