

Terms & Conditions of engagement against above temporary positions :-

1. The engagement for RA and SRF will be initially up to March, 2023 to till further orders. However, it is extendable upto five (05) years or till the date of termination of project, whichever is earlier. The appointment is purely temporary and co-terminus with the duration of the project subject to satisfactory performance.
2. The crucial date for determining the age limit shall be the date of Interview.
3. The **selected candidates** will be initially posted **at RC- Koraput**. However, he/she can be posted any where preferably within Odisha State as per the requirement of the Project without any extra payment except emoluments. Project sites located at Koraput & Nabarangpur
4. The positions are purely time bound, temporary on co-terminus basis with the Project and do not entitle the appointment to any claim implicit or explicit on any ICAR post.
5. The essential qualification given in the advertisement against each position is minimum. Candidates possessing higher qualification in the relevant fields may also be considered for these positions subject to their suitability of the position.

6. Only passed out candidates are eligible to apply. Candidates awaiting final results are not eligible and need not apply.
7. While appearing for walk-in-interview, all applicants shall submit their application in the proforma attached alongwith this Advt. which is also available on the Institute's website with latest photograph alongwith self attested copies of the relevant certificates in support of age, educational qualifications, experience etc. In case an applicant is appearing for walk-in-interview for more than one position, separate application for each position will be required.

9. In case the number of candidates is large enough, the competent authority reserves the right to fix the criteria to limit the candidate on the basis of qualification, experience etc.
10. Persons already in employment should attach "No Objection Certificate" issued by their present employer with the application.
11. No TA/DA will be paid either for attending interview or to the selected candidate to join the position.
