- 1. Age limit: Maximum age 35 years for men and 40 years for women (age relaxation of five years will be given to SC/ST and three years to OBC candidates as per Govt. of India's rules)

- 3. Crucial date for determining the age limit shall be the date of walk-in-interview.
- 4. Candidates awaiting final result of the essential qualifications are not eligible, hence need not to appear in walk-in-interview.
- 5. The positions are purely temporary on co-terminus basis and do not entitle the appointment to any claim implicit or explicit on any ICAR post.
