5. No TA/ DA will be paid for attending the Interview
6. Separate application will be required for each position.
7. For SC/ST candidates, an age relaxation of 5 years, and 3 years for OBC candidates will be given as per Govt. of India/ICAR rules.
8. All the selected candidates should have good health and produce medical fitness and character certificates from two referees
9. **The selected candidates for the NMSHE project are liable to be posted initially at Dakpathar, Uttarakhand but may also be posted in any place(s) for enabling the project work in the field in the Indian Himalayan Region and governed by DST/ICAR norms as being issued from time to time.**
10. The selected candidate for the above positions should have good health. The selected candidates may have to visit any place in India, if need arises on official work
