- 7. Battery weight should be varied 1.3 Kg to 1.4 kg.
- 8. Battery endurance not less than 40 minutes with payload.
- 9. One year / 500 cycle full warranty if any is battery should be replaced.
- 10. Battery should be support hot-swapping. Battery should be compatible with Kam DJI Matrice 300 RTK.
