## **Auction Notice**

Name of the produce: Tamarind

An open auction is scheduled for the sale of fruits of Tamarind at Research Farm, Sunabeda the land produce at the Research Farm of this Centre shall be held at ICAR - Indian Institute of Soil & Water Conservation, Research Farm, Sunabeda on 27/01/2023 at 15.00hrs. All the interested bidders are invited to take part in the auction. The terms and conditions of the auction are as under:

- 1. The detailed terms & conditions are available on website of this Institute (www.cswcretiweb.org) and CPP Portal.
- 2. An Earnest Money Deposit of Rs.5000/- (Rupees Five thousand only) in the shape of demand draft drawn in favour of "Head of the Centre, ICAR-IISWC" payable at State Bank of India, Sunabeda must be deposited or proof of depositing the amount through any means of e-payment or through POS along with tender form failing which tender shall be rejected.
- 3. The security amount of the unsuccessful parties will be refunded immediately after the finalization of the auction.
  - 4. The party in whose favour the rate is accepted has to deposit 80% of the total cost of the amount immediately soon after finalization of the auction and the rest 20% of the auction amount within 3 days from the date of receipt of the office order, failing which the amount deposited in the office will be forfeited to the Government Account.
  - 5. The validity of quotation/bid should be 90 days from the date of opening of quotation/bid.
- 6. The awarded firm / party should ensure for watch & ward, application of basal dose, weeding, cutting, transportation, threshing, bagging the harvested in the specified area only.
  - 7. The awarded firm should allow the Scientist, Technical Officer, Technicians, I/c.Farm Supdt during their visit to the area for collecting data etc.
    - 8. The fieldworks to be carried out as per normal practice and the area should be maintained properly by cleaning etc. All other instructions will be given by the I/c.Farm Supdt./OIC(Farm) from time to time for better maintenance of the crop area.

- 9. The surrounding area(s) should be well maintained by scraping weeds and the debris should be removed from the area(s). All the inputs including fertilizer, pesticides are to be arranged at your own cost as per normal practice. Prior approval may be taken from the OIC (Farm) for arranging necessary advice and supervision.
  - 10. If any disease is observed, the same should be reported to the OIC (Farm)/Farm Supdt.

    Necessary protection measures should be taken and protected under the guidance of Scientists / OIC (Farm) / Farm Supdt. of the Centre.
  - 11. The harvesting, and its transport to be done by the successful bidder and labourers have to be arranged by him at his own cost. Harvesting of crops will have to be done between 10.00 A.M. to 5.00 P.M. on working days only and transportation should made through main gate only.
  - 12. The area and its surroundings may be maintained neat and clean which may serve demonstration value to the farming community.
  - 13. Inputs data and harvest produce details are to maintained in a register and should be made available to the Research Centre on quarterly basis for Research analysis and publication purpose.
  - 14. The Research Centre or Institute is not responsible for any kind of incidents including loss of life. It is sole responsibility of the bidder to bear the loss on paying compensation to the workers in case of any accident, loss of death etc.
  - 15. The area and other experimental and other crop area(s) should not be damaged and if any damage is observed, the cost will be recovered from the successful bidder at the discretion of the undersigned. Cutting and carrying of any firewood and grasses are strictly prohibited.
  - 16. The rate may be quoted after inspecting the areas. The inspection may please be done during the working hours from 10.00A.M. to 5.00P.M. The OIC (Farm)/I/c. Farm Supdt. may please be contacted for further information.
  - 17. The date of auction at this Centre is on <u>27.01.2023 at 15.00hrs</u>. The bidders or his representative can be present at the time of auction. If the highest bid quoted is not satisfactory, the Competent Authority reserves right to auction among the bidders who have participated bid process or re-auction or cancel the auction.
  - 18. E.M.D. of Rs.5,000/- (Rupees Five Thousand only) through POS / Demand Draft favoring "**Head of the Centre**", ICAR-IISWC payable at SBI, Sunabeda should accompany the bid which will be refunded to the unsuccessful bidder except the successful bidder.
  - 19. This centre will not allow the participants who have not deposited the EMD.
  - 20. The party / person deposited the EMD is only allowed in the bid process.
  - 21. The undersigned reserves the right to accept or reject the auction without assigning any reason. The successful bidder should deposit 80% of the quoted amount as advance on the next day and balance 20% shall be remitted within 10 days. The bidder will be allowed to harvest only on receipt of 100% of total value accepted.
